### Investment Philosophy: Disciplined Security Selection



The Short Government Fixed Income Composite was created on February 1, 2015, with an inception date of February 1, 2015. All returns are based in U.S. Dollars and are computed using a daily time-weighted total rate of return. The composite is defined to include fee-paying discretionary accounts that are managed according to the Short Government Fixed Income strategy, including those accounts no longer with the firm. For comparison purposes, the composite is measured against the Bloomberg 1-3 Yr Government Bond Index. There is no minimum account size for this composite. The dispersion of annual returns is measured by the standard deviation of asset-weighted portfolio returns represented within the composite for the full year. The three-year annualized ex-post standard deviation of the composite and benchmark is not presented because 36 monthly returns are not available.
